ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Mar Baselios B.Ed. College, Sultan Bathery P.O. Wayanad District, Pin – 673592, Kerala had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for starting Secondary course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

- On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - a) The institution has acquired the land for setting up the teacher education institution.
 - b) The institution has created an Endowment Fund of Rs. 5.00 Lakhs and a Reserve Fund of Rs. 3.00 Lakhs.
 - c) The institution has selected the Principal / Head and **Seven** teachers for the said course and the staff list is approved by Calicut University.
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Mar Baselios B.Ed. College, Sultan Bathery P.O. Wayanad District, Pin 673592, Kerala for Secondary course of one year duration from the academic session 2004-2005 with an annual intake of 100 students subject to fulfillment of the following.
 - a) The institution will ensure that **Eight** faculty members are in position for an intake of **100** students before commencement of the course and a report to this effect shall be sent to the Committee immediately and in any case not later than one month from the date of commencement of the course.
 - b) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.

- c) The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).
- d) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC / University / State Government etc.,
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University for the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution Mar Baselios B.Ed College, Sultan Bathery P.O. Wayanad District, Pin -673592, Kerala has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.
- 3. AND WHEREAS, on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 23.02.2005.
- **4. AND WHEREAS**, the SRC has decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
 - I. The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
 - II. The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution dose not fulfill required norms of infrastructure recognition will be withdrawn.
 - III. Further, with regard to the second unit the institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
 - V. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- **5. NOW THEREFORE,** in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition **Mar Baselios B.Ed College, Sultan Bathery P.O. Wayanad District, Pin -673592, Kerala** for conducting **B.Ed** programme of **two** years duration with an annual intake of **100** students each for two basic units from the academic session **2015-16** subject to fulfillment of the conditions mentioned at 4.(II) and 4.(II) herein before 31 July, 2015 and those mentioned at 4.(III), 4.(IV) before 31 10.2015.

- **6.** Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- 7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

a) Sanctioned programmes along with annual intake in the institution:

b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c) Name of faculty members who left or joined during the last, quarter:

d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e) Fee charged from students;

f) Available infrastructural facilities;

g) Facilities added during the last quarter;

h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

i) The affidavit with enclosure submitted along with application.

i) The institution shall be free to post additional relevant information. if it so desires.

k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
