#### ORDER

Provisional affiliation was granted to Mar Baselios B.Ed. College (Un-Aided), Sulthan Bathery, Wayanad for starting B.Ed. degree programme during the academic year 2004-'05, with permission to start classes during the academic year 2005-'06, with an intake of 100 students, vide U.O. read as (1). The name of the college was changed from 'Mar Baselios B.Ed. College' to 'Mar Baselios College of Education', vide U.O. read as (2.)

2. As per the National Council for Teacher Education (NCTE) Regulations, 2014, the B.Ed. programme shall be of a duration of two academic years, and the intake shall be a basic unit of 50 students, with a maximum of two units. The NCTE permitted the College for conducting B.Ed. programme with an intake of 100 students (50 x 2 unit) from the academic year 2015-'16 onwards vide paper read as (3).

3. Permission was granted to consider the applications received from the training colleges at the beginning of each academic year as in the case of other courses and grant continuation of provisional affiliation without insisting orders for extension of approval from the NCTE, vide U.O. read as (4).

4. A revised permanent seat distribution among the optional subjects of B.Ed. programme w.e.f. the academic year 2020-'21, was granted, vide U.O. read as (5). Continuation of Provisional Affiliation was granted to the B.Ed. programme at the College for the academic year 2022-'23, vide U.O. read as (6).

5. The Principal has requested to grant Continuation of Provisional Affiliation to the B.Ed. programme for the academic year 2023-'24, vide paper read as (8).

6. The Higher Education Department, Government of Kerala have renewed NOC for conducting self financing B.Ed. programme for 2023-'24, vide G.O. read as (9).

7. Considering the above, sanction has been accorded by the Vice Chancellor to grant Continuation of Provisional Affiliation to the self financing B.Ed. programme with an intake of 100 students (50 x 2 unit) at Mar Baselios College of Education (Un-Aided), Sulthan Bathery, Wayanad for the academic year 2023-'24 with strict directions to the Principal to appoint faculties with the qualifications prescribed by NCTE.

- i. Affiliation granted is strictly provisional and only for the academic year 2023-'24.
- ii. The Principal is strictly directed to engage faculties with qualifications prescribed by NCTE and to comply with the provisions of the Kerala Self Financing College Teaching and Non-Teaching Employees (Appointment and Conditions of Service) Act 2021 (ACT 13 of 2021).
- iii. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and the directions issued by the University/Government from time to time.
- iv. Conduct of University Examinations of any sort, including that of SDE is compulsory and binding on all Colleges affiliated with the University of Calicut.
- v. In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form.
- vi. Violation of any of the above will lead to cancellation of affiliation.
